## REACH COMPLIANCE DECLARATION STATEMENT – June, 2023

REACH (Registration, Evaluation, Authorization and Restriction of Chemicals) is a European Union Commission (EUC) Regulation on chemicals and their safe use. The REACH Regulations became effective on June 1, 2007 and continue to be phased in.

REACH establishes specific duties and obligations on a business which manufactures or imports a substance or article that includes a “**substance of very high concern**” (SVHC) in concentrations of more than **0.1% w/w**. A substance which is listed on the “**Authorization List**” published by the European Chemicals Agency (ECHA) (Annex XIV of the REACH Regulations) cannot be manufactured or imported in the EU after a fixed date unless the ECHA authorizes the use of the substance for a specific use or uses. **As of June 14, 2023, there were 235 substances on the SVHC.**

The use of substances listed in Annex XVII of the REACH Regulations are banned in all articles or substances produced or imported in the EU except to the extent that the use complies with the specific restrictions contained in Annex XVII.

Upon review of the formulations of the above listed products, and to E-Z LOK's best knowledge:

(1) E-Z LOK products do contain a substance (**Lead**) that was recently added to the **REACH Candidate List** of "Substances of Very High Concern" (SVHC) as published by the ECHA on its website, in excess of the applicable legal thresholds (**0.1% weight / weight**); and

(2) SVHC substance (**Lead**), while recently being included on the current **REACH SVHC Candidate List**, has not been placed on the **REACH Authorization List** or assigned a **Sunset Date** at this time.

(3) All other substances contained in E-Z LOK products are currently in substantial compliance with the conditions and restrictions of Annex XVII of the REACH Regulations.

E-Z LOK will endeavor to appropriately update or modify this REACH Compliance Declaration Statement should any changes occur in the composition of E-Z LOK's products or the REACH regulations, including the addition of any substances to the SVHC Candidate List, the Authorization List, or Annex XVII of the REACH Regulations.
