2. On January 6, 2021 the U.S. Environmental Protection Agency (EPA) published a final rule prohibiting the processing and distribution of five (5) different PBT chemicals under section 6(h) of the Toxic Substances Control Act (TSCA).

Based upon information provided to us from our suppliers, a review of the applicable Safety Data Sheets (SDS's) for the materials used in MSC products, and to the best of our knowledge, E-Z LOK hereby certifies that the supplied machined products do not contain any of the following prohibited chemicals:
